Fire Safety - Angela Bird

The HOA meeting included a guest speaker, Angela Bird, from the Division of the Fire Marshal. Here are a few highlights. There are informational packets available - just let a board member know if you would like a packet.

- Restrictions are in place for multi-use structures using open flame or charcoal.
- Do not use dryer sheets for wiping off dryer lint vents, as this can cause a fire.
- Do not use fire extinguisher or hose for a house fire, instead get out of the building. Have an escape plan and a meeting place for your family. Don't forget to have a plan for your pets!!

A Wildfire Mitigation representative will be walking the property on June 1st at 1:00 PM if anyone is interested in joining.
